The Rideau — A Safer Place

Parks Canada and the Ottawa Police are working together to make the Rideau Canal a safer place through enforcement and promotion of responsible boating. This summer there has been an increased presence on the water, allowing for more interaction with boaters. During several patrols, more than 30 charges were laid in the Northern Section of the Rideau Canal, primarily for failure to comply with a posted no wake/speed sign. Parks Canada is educating boaters on the benefits of boating safely and watching their wake. They are also installing new signs that will clearly identify where the “no wake zones” begin and end. The Conservation Partners (MVC, SNC and RVCA) hosted this one-day workshop in April 2011 to a full capacity audience and rave reviews. Perfect for municipal site inspectors, consulting engineers and drainage superintendents, this interactive workshop targets strategies for developing effective Erosion and Sediment Control Plans that can actually be implemented on a construction site. Traditionally this industry has focused on the installation of devices such as silt fence and check dams; however, it's time to move beyond the cookie cutter approach to a more integrated process that addresses erosion control, sediment control and environmental awareness. project included a landowner opinion survey. It identified boat speed, noise and wake as a major problem on the Rideau. Controlling boat wakes will reduce damage to shorelines, meaning less suspended sediment and nutrient loading, and hence better water quality and aquatic habitat in nearshore areas.

Low Water Response — Time to Know about Low Flow

Periods of dry weather and low water levels have been relatively uncommon in Ontario. However, changing weather patterns indicate that low water levels may become more common. Working with local municipalities, the RVCA has developed “low water response” procedures that reflects our watershed’s local needs and conditions. In times of low flow, the RVCA will work with member municipalities and other agencies to form a local Water Response Team that will develop a strategy on how to respond to local water issues — this includes ongoing monitoring, responding to shortages and public communication.

Who to Call? Common Work Projects at a Glance

When doing work in or near a public waterway, you may need approval from one or more government agencies before starting your project. Municipalities deal with planning applications and building permits. Parks Canada reviews work plans to protect Crown land (such as the bed of the Rideau Canal). RVCA looks at flooding, pollution and conservation of land. **Please share this chart with your staff and constituents.**
