PUBLIC ADVISORY COMMITTEE HOLDS FIRST MEETING TO DISCUSS RIDEAU LAKES WATERSHED PLAN

MANOTICK, DECEMBER 5, 2005 — The first meeting of the Public Advisory Committee (PAC) was held on Nov. 14. The PAC is made up of interested citizens in the Rideau Lakes area (extending from above Wolfe Lake west of Westport to the Lower Rideau Lake) who would like to assist in developing a plan that will help improve the health of the Rideau Lakes and the surrounding lands.

The committee discussed the importance of getting information out to the public to ensure they understand that they have a role in protecting their local environment, economy and health.

Terms of Reference were agreed to and listed the issues that will be addressed in the plan. These include: water quality, weed growth, fisheries management, shoreline development and health, tourism and recreation and balancing the economy with personal and environmental health.

The vision that watershed stakeholders have for the area is:

All residents, visitors and other stakeholders are knowledgeable environmental stewards committed to working together to ensure this unique watershed is diverse, healthy, safe and clean, where the thriving local economy exists in harmony with the thriving ecosystem for future generations.

With that lofty goal in mind, the PAC members stated they would like to assist members of the public to get involved in the plan (which will ultimately affect everyone living in the vicinity of the Rideau Lakes) by allowing themselves (the members) to be information contacts.
