## 5.0 Business Arising from the Minutes

Agenda Item 9.0 – RVCA Office Roof Repair

Chair Leenhouts clarified that he had misunderstood part of the discussion and now realizes that the existing roof on the building will not be removed and that the remediation product that was approved will be applied overtop of the existing. He extended his apologies to Terry Davidson and Shane Olive for the way in which he responded to the agenda item.

## 6.0 Bilberry Creek Specialized Geotechnical Investigation (Phase II)

Terry Davidson, Director of Engineering and Regulations, updated the Board on Phase II of the Hazard Mapping for Bilberry Creek and responded to questions.

Mr. Davidson answered questions about how RVCA's regulations would apply to development and redevelopment in the area once the factor of safety and setback lines are determined. He also confirmed that RVCA and City of Ottawa staff are working together with the local Councillors on a communications strategy which will include a public open house and direct mail notice.

Stability Assessment and Hazard Analysis) at a cost of \$119,921 plus HST subject to a signed funding agreement with the City of Ottawa; and

THAT RVCA staff be allowed to approve Additional Investigation Requirements (15% contingency) up to a total maximum of \$17,988 plus HST to complete hazard mapping.

## 7.0 COVID-19 Pandemic Response Update

Sommer Casgrain-Robertson, General Manager, gave an update on RVCA's response to the COVID-19 pandemic and responded to questions.

In response to a suggestion from a member, Sommer Casgrain-Robertson agreed that COVID signage should be installed at Conservation Area water access points.

Pieter Leenhouts recommended that Board members consider downloading the federal COVID Alert application.

Dan Cooper, Director of Conservation Lands and Stewardship, answered questions about RVCA's Forest School being offered at Foley Mountain and Baxter Conservation Areas. He explained that a maximum of sixteen children attend one day per week for a total of 12 weeks and that a Kinder Program (ages 3 to 5) is offered one half day per week and the other four days are open to students ages 4 to 10.

Conservation Ontario is developing a pre-consultation guidance document which outlines best practices for pre-consultation between conservation authorities, municipalities and planning and regulation clients. It is anticipated that this document should roll out this Fall.

- b) AMO Virtual Conference: August 17-19. 2020 Sommer Casgrain-Robertson noted that Minister Yurek was asked about the status of *Conservation Authorities Act* review and responded that his ministry is working on regulatory and legislative changes for this Fall.
- c) Eastern Ontario CA General Managers: August 25, 2020 Sommer Casgrain-Robertson confirmed that this group continues to meet on a regular basis which has been very beneficial.

  Sommer Casgrain-Robertson advised that the Eastern CAs have been successful in securing two speaking sessions at this year's two-day virtual conference. CA staff are currently working on pulling together a joint 45-minute presentation which will address Development Review and Changes to the *Conservation Authorities Act*.

Sommer Casgrain-Robertson presented the following correspondence:

Regarding items a) and b), Sommer Casgrain-Robertson advised that it is not too late for municipalities to pass a resolution of support for local conservation authorities as the Ministry of Environment, Conservation and Parks has not introduced the next round of changes yet to the *Conservation Authorities Act*. In response to a question, Ms. Casgrain-Robertson confirmed that the City of Ottawa has not submitted a resolution but has on numerous occasions expressed its support for Mississippi Valley Conservation Authority, Rideau Valley Conservation Authority and South Nation Conservation in delegations with Provincial Ministers. The City is also working with the conservation authorities to determine the best way for the City to express its support.

Regarding items c) and d), Sommer Casgrain-Robertson noted that Mississippi Valley Conservation Authority had raised concerns about shortfalls in Water and Erosion Control Infrastructure (WECI) funding and potential adverse impacts on municipal budgets. Ms. Casgrain-Robertson directed Members to the draft Motion on Page 22 of the Board package and indicated that the Board could endorse the motion if they were in support of the position taken by MVCA. George Sachs confirmed that Drummond/North Elmsley had supported MVCA's motion on Tuesday evening. Barclay Cormack recommended that the RVCA Board endorse and support the draft motion, especially for the carry-over of funds. Ms. Casgrain-Robertson walked through the motion with the Board and indicated what amendments should be made to make it appropriate for RVCA, amendments included removing the fourth whereas statement, changing "MVCA" to "CAs" and "this municipality" to "municipalities in the fifth whereas statement, and changing "CAO" to "GM" and "Council" to "the Board of Directors" in the be it resolved statement.

Ms. Casgrain-Robertson also clarified that MVCA has sent the attached letter and draft motion to municipalities within the Mississippi Valley watershed which includes some of RVCA's member municipalities.

**Whereas** the province reaffirmed its commitment to "continue its cost share funding arrangement with municipalities to...support high priority repairs to conservation authority infrastructure" in its March 2020 *Ontario Flooding Strategy;* 

**And whereas** the province allocated \$5 million annually for this purpose in 2003 and has not increased or indexed the funding envelop in 17 years;

**And whereas** demand for replacement and upgrade of water and erosion control assets is ever increasing due to aging infrastructure and the impacts of climate change;

**And whereas**, should funding not be received from the province for these and other conservation authority capital projects, the burden of those costs will fall in part to municipalities;

**Now therefore**, be it resolved that the General Manager draft a letter on behalf of the Board of Directors for submission to the Minister of Natural Resources and Forestry, the Minister of Environment, Conservation and Parks, and the Minister of Municipal Affairs and Housing supporting the letter from the MVCA and requesting that funding of the Water and Erosion Control Infrastructure (WECI) program be significantly increased and that program rules be adjusted to allow for reasonable construction periods and the carry-over of funds between fiscal years.
