6.0 <u>Land Donation: Oblates Property</u>

Steve Cunliffe of The Regional Group of Companies and Paul Smolkin of Golder Associates gave a presentation on the proposed land donation of a 30 metre buffer along the Rideau River on the Oblates property (Greystone Village development). They spoke to the history of the property and responded to questions regarding historical contamination on the site. It was confirmed that should the property be donated to the RVCA, it would be remediated in accordance with MOECC guidelines and will have complied with all planning and permitting requirements of the City of Ottawa meaning that the property should be turn-key ready with no further investment required.

Through a show of hands, the Board agreed that staff should continue discussions with The Regional Group about potentially accepting the property. Another staff report will be brought to the Board at a later date outlining more details of the potential land donation at which time the Board can decide whether or not to accept the offer.

7.0 Black Rapids Creek Wetland Restoration Project

Jennifer Lamoureux, RVCA Aquatic and Fish Habitat Biologist, gave the attached presentation regarding the proposed Black Rapids Creek Wetland Restoration Project, a partnership between RVCA and the NCC. Ms. Lamoureux responded to questions regarding the project.
