7 Millionth Tree Takes Root in Richmond


Ottawa Mayor Mark Sutcliffe and Elizabethtown-Kitley Mayor Brant Burrow helped plant RVCA's seven millionth tree since 1984 at a ceremony in Richmond on May 13. RVCA offers generous financial and technical support for rural landowners to complete large-scale planting on their properties. Ottawa landowners have planted more than 2 million trees since the program began, while Elizabethtown-Kitley landowners have planted more than 600,000.

Septic re-inspections are underway

Our septic inspectors have begun their work in the Tay Valley, Township of Rideau Lakes and Central Frontenac as part of the municipalities' mandatory re-inspection programs. Re-inspecting existing septic systems helps protect local water quality by catching malfunctioning or leaking systems before they contaminate the local environment.
